- 3. In the reference third cited, the University had granted the order of Continuance of Provisional Affiliation to Government Siddha Medical College, Palayamkottai for conducting B.S.M.S Degree Course with an annual intake of 100 seats for the academic year 2018 2019.
- 4. In the reference fourth cited, the Government of India, Ministry of Ayush, New Delhi had Granted Conditional Permission to the Government Siddha Medical College, Palayamkottai, Tirunelveli 627 002, Tamil Nadu with 100 seats in UG(BSMS) Course for the academic session 2019-2020 under section 13C/13A of the IMCC act, 1970.
- 5. Due to Covid-19 Pandemic, the University inspection of the B.S.M.S Degree Course with an annual intake of 100 seats for the academic year 2020 2021 could not be conducted. The Resolution No.4 (4) passed at the 277<sup>th</sup> Governing Council meeting held on 30.09.2020.

Based on the resolution the said institution was informed to submit undertaking for inspection and necessary fee by mail dated 05.01.2021 and letter dated 01.03.2021. The same has to be received from the institution.

- In the reference third cited, the University had granted the order of Continuance of Provisional Affiliation to Government Siddha Medical College, Palayamkottal for conducting M.D. (Siddha) Degree Course with an annual intake of 60 seats for the academic year 2018 - 2019.

In the reference fourth and fifth cited, the inspection was conducted on 15.07.2919 to verify the Infrastructural facilities, teaching faculties and other facilities for grant of the Order of Continuance of Provisional Affiliation for conducting the M.D (Siddha) degree course with an annual intake Sixty (60) seats for the academic year 2019 2020, and the inspection Commission has submitted the Inspection report.
